KEY AREAS OF FOCUS

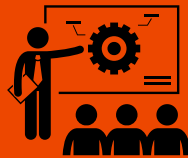
- **Entrepreneurial Development:** INCOC supports small and medium-sized enterprises (SMEs) through mentorship, training programs, and networking opportunities.
